3. Pitt County policy requires that we recycle cans and cardboard, so sites will be provided for disposal.
4. INSIDE EXHIBITORS MUST MOVE EXHIBITS IMMEDIATELY AFTER THE CONCLUSION OF THE FAIR.
5. Manager may close any concession that is not being operated in accordance with the provisions of this contract...
6. Lessee will not use or allow to be used any loud speakers without the permission of the fair manager.
7. LESSEE WILL CONFINE ITS SERVICE TO THE INSIDE OF ITS STAND OR BOOTH AND WILL KEEP THE AREA CLEAN.
8. Lessee releases and discharges the Pitt County American Legion Agricultural Fair, Inc., and their respective agents, servants, employees, and officers from any and all claims arising out of death, personal injury, or property damage suffered or incurred as a result of Lessee participation in the fair.
9. GATE PASSES: Please make sure that all workers understand the pass policy:
2 FREE 6 day passes with 10' X 8' space.
4 FREE 6 day passes with 20' X 8' space.
6 FREE 6 day passes with permanent concession buildings.
FREE SPACES - UNMANNED SPACES: NO PASSES!
ADDITIONAL DAILY PASSES MAY BE PURCHASED AT THE FAIR OFFICE FOR \$4.00 EACH BY THE CONTRACT SIGNEE.
